Bigibility Criteria	1. Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Otizen Immigration Services and verified through OSForm g-845; or have been granted asylum along with the approved Notice of Action issued by the Otizen Immigration Services.

- 5. Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline. The completion of the application form does not create an obligation to award a scholarship to the applicant.
  - a. As part of the scholarship application, the University of Phoenix

- i. Applicant has completed a minimum of 9 credits at the University of Phoenix and has at least 9 credits remaining in their University of Phoenix master program as of the Scholarship application deadline.

- iii. Applicant has a minimum GPA of 3.85 (on a 4.0 scale) as of the Scholarship application deadline
- Applicant must be actively enrolled and attending the University of Phoenix for a Window.

## Selection Process

- 1. The recipients of the scholarships will be selected by the University of Phoenix.
