

<p>Summary</p>	<p>All current University of Phoenix degree students who are actively enrolled in a University of Phoenix master’s degree program who i have taken a minimum of 9 credits at the University of Phoenix and have at least 9 credits remaining in a University of Phoenix master’s degree program; ii have an aggregate GPA of . or higher on a . scale in their current master’s degree program; iii have not had an unapproved break in attendance greater than 14 days in the last 365 days except for an approved leave of absence as of the scholarship deadline; and apply for this Academic Achievement Master's Scholarship (Current Students) December 2022 ("Scholarship") prior to the deadline and post attendance in a class between December 1st, 2022 and December 31st, 2022 "Initial Attendance Window" will have the opportunity to be considered for one of fifteen scholarships up to \$2,000 each.</p> <p>Students must begin the admissions application prior to completing this scholarship application</p>
<p>Application Deadline</p>	<p>The Scholarship application will be made available online on December 1st, 2022. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST December 31st, 2022 "Application Deadline" . Applications submitted after the Application Deadline will not be considered. No exceptions.</p>

Eligibility Criteria

	<ol style="list-style-type: none"> 5. Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline. The completion of the application form does not create an obligation to award a scholarship to the applicant. <ol style="list-style-type: none"> a. As part of the scholarship application, the University of Phoenix will review the applicant's official University of Phoenix student account and transcripts to verify the following requirements: <ol style="list-style-type: none"> i. Applicant has completed a minimum of 9 credits at the University of Phoenix and has at least 9 credits remaining in their University of Phoenix master's degree program as of the Scholarship application deadline. ii. Applicant has not had an unapproved attendance break of greater than 14 days in the last 365 days as of the Scholarship application deadline. iii. Applicant has a minimum GPA of 3.85 (on a 4.0 scale) as of the Scholarship application deadline 6. Applicant must be actively enrolled and attending the University of Phoenix for a bachelor's degree program within the Initial Attendance Window.
<p>Selection Process</p>	<ol style="list-style-type: none"> 1. The recipients of the scholarships will be selected by the University of Phoenix. 2. It is the applicant's responsibility to submit a complete and signed application along with any required and supporting documentation, which must be received on or before the Application Deadline. The University of Phoenix accepts no responsibility for incomplete applications, applications not in proper form, lost applications, or any other submission in exception to the instructions. 3. Scholarship selection shall be made without regard to race, color, religion, sex, sexual orientation, gender identity, age, national origin, disability, veteran status, or any other category protected by federal, state, or local law. 4. The 15 scholarships will be awarded to the eligible applicants with the highest GPA that apply by the application deadline. In the event there are applicants with the same GPA, the applicant(s) with the earliest date of application will receive the scholarship. 5. The decision of the University of Phoenix is final and not subject to review. 6. Starting on January 3rd, 2023, the University of Phoenix will begin the selection process for eligible qualified students. 7. Recipients will be notified no later than February 8th, 2023.

Scholarship Award
Distribution and
Timing

The University of Phoenix will determine and notify the recipients of the scholarships upon validation.

1. The maximum Scholarship award is \$2,000. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$185 per course until: (i) the student completes 10 courses, after which a final disbursement of \$150 will be applied toward the eleventh course, thus maximizing the \$2,000 total Scholarship amount, or (ii) two years

Upon the submission of the application by applicant or the award of the scholarship and recipient's acceptance, University of Phoenix, Inc., including its affiliates as well as its agents, and others working for it on its behalf or at its direction and their respective licensees, successors, and assigns, shall have the right to use and republish the submitted

If recipient has applied for or is receiving Title IV financial aid funding, this scholarship may reduce the recipient's eligibility for Title IV financial aid funding to comply with Title IV regulations. In addition, the recipient must maintain continuous attendance as defined by the University of Phoenix and/or must qualify for a leave of absence to maintain his/her financial aid status.
