Application Deadline	The Scholarship application will be made available online on December 1 st , 2022. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST December 31 st , 2022 "Application Deadline". Applications submitted after the Application Deadline will not be considered. No exceptions.

Eligibility Criteria

- 5. Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline. The completion of the application form does not create an obligation to award a scholarship to the applicant.
 - a. As part of the scholarship application, the University of Phoenix will review the applicant's official University of Phoenix student account and transcripts to verify the following requirements:
 - i. Applicant has completed a minimum of 9 credits at the University of Phoenix and has at least 9 credits remaining in their University of Phoenix master's degree program as of the Scholarship application deadline.
