Selection Process	<p>a. As part of the scholarship application, the University of Phoenix will review the applicant's official University of Phoenix student account and transcripts to verify the following requirements:</p> <ul style="list-style-type: none"> <li>i. Applicant has completed a minimum of 9 credits at the University of Phoenix and has at least 9 credits remaining in their University of Phoenix master's degree program as of the Scholarship application deadline.</li> <li>ii. Applicant has not had an unapproved attendance break of greater than 14 days in the last 365 days as of the Scholarship application deadline.</li> <li>iii. Applicant has a minimum GPA of 3.85 (on a 4.0 scale) as of the Scholarship application deadline</li> </ul> <p>6. Applicant must be actively enrolled and attending the University of Phoenix for a master's degree program within the Initial Attendance Window.</p>

Applicant must remain in a master's program (all coursework attended must be program applicable courses). Awards will only be applied to courses taken as part of their master's program, specific to the original program level award.</li> <li data-bbox="500 695 1406 869">2. Applicant must successfully pass each course attempted in accordance with their program's requirements as outlined in the academic catalog for all courses. Any withdrawals or courses not successfully passed in accordance with the program requirements will terminate the scholarship.</li> <li data-bbox="500 875 1406 940">3. Applicant may not have an unapproved attendance gap greater than 35 days.</li> </ol>
