This Scholarship is not applicable and will not be issued to:<ol style="list-style-type: none"><li>a. Applicants who enroll in a University of Phoenix degree level or program other than what is specifically outlined in the Application's Eligibility Criteria for the scholarship.</li><li>b. Applicants pursuing stand-alone University of Phoenix courses.</li><li>c. Applicants pursuing stand-alone University of Phoenix certificates.</li><li>d. Applicants pursuing a Competency Based Education program</li><li>e. Current University of Phoenix Students</li><li>f. University of Phoenix Alumni</li><li>g. Applicants receiving any employer benefits or discounts</li><li>h. Applicants receiving Military Tuition Rate</li><li>i. Applicants who do not meet the University of Phoenix eligibility requirements</li><li>j. Students who enroll and start their first course outside the scholarship window.</li><li>k. Recipient is Academically Disqualified, Disqualified for Admission, Scholastically Disqualified, Scholastically Suspended or Expelled as outlined in the University Catalog.</li><li>c. Recipient is out of attendance on an unapproved leave of absence for more than 35 days.</li><li>d. Recipient completes their master's degree program.</li><li>e. Receives the maximum scholarship award</li><li>f. 730 days from a recipient's first course.</li></ol></li><li>7. If recipient has applied for or is receiving Title IV financial aid funding, this scholarship may reduce the recipient's eligibility for Title IV financial aid funding to comply with Title IV regulations. In addition, the recipient must maintain continuous attendance as defined by the University of Phoenix and/or must qualify for a leave of absence to maintain his/her financial aid status.
