Summary	All new students or students who have been out of attendance for over 365 days who i) apply for and enroll in a University of Phoenix master's degree program; (ii) have three year's work experience and (iii) apply for this Phoenix Master's Summer Scholarship – June 2022 ("Scholarship") prior to the deadline and register and post attendance in their first class between June 1 st , 2022 and June 30 th , 2022 ("Initial Attendance Window") will receive a scholarship up to \$3,000 each.
Application Deadline	The Scholarship application will be made available online on May 1 st , 2022. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST June 30 th , 2022 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	 Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services.
	2. Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient.
	3. Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc.
	 Applicant must apply and be admitted to a University of Phoenix master's degree program.
	 Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline. Selection Process	 The recipients of the scholarships will be selected by the University of Phoenix.

Scholarship Award Distribution and Timing	The University of Phoenix will determine and notify the recipients of the scholarships upon validation.
	1. The maximum Scholarship award is \$3,000. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$273 per course until: (i) the student completes 10 courses, after which a final disbursement of \$270 will be applied toward the eleventh course, thus maximizing the \$3,000 total Scholarship amount, or (ii) two years has elapsed from the student's first date of attendance in the their first course, or (iii) the student graduates from their program, whichever comes first.
