|   | <ul style="list-style-type: none"> <li>a. Must have received a minimum of 13 cumulative credits but no more than 60 credits.</li> <li>b. Transfer students who are new to the University will not be eligible for this Scholarship if they've received more than 60 credits.</li> <li>c. Official transcripts must be received, and the applicant must be officially evaluated and fully admitted into the University of Phoenix by the last date of their first registered course.</li> <li>d. This Scholarship only applies to new transfer students who meet the above criteria.</li> </ul> <p>7. Applicant must post attendance to their first bachelor's degree course within the Initial Attendance Window.</p>   |
| Selection Process                         | <ul style="list-style-type: none"> <li>1. The recipients of the scholarships will be selected by the University of Phoenix.</li> <li>2. It is the applicant's responsibility to submit a complete and signed application along with any required and supporting documentation, which must be received on or before the Application Deadline. The University of Phoenix accepts no responsibility for incomplete applications, applications not in proper form, lost applications, or any other submission in exception to the instructions.</li> <li>3. Scholarship selection shall be made without regard to race, color, religion, sex, sexual orientation, gender identity, age, national origin, disability, veteran status, or any other category protected by federal, state, or local law.</li> <li>4. The decision of the University of Phoenix is final and not subject to review.</li> <li>5. Starting on August 1<sup>st</sup>, 2022, the University of Phoenix will begin the selection process for eligible qualified students.</li> <li>6. Recipients will be notified no later than September 1<sup>st</sup>, 2022.</li> </ul> |
| Scholarship Award Distribution and Timing | <p>The University of Phoenix will determine and notify the recipients of the scholarships upon validation.</p> <ul style="list-style-type: none"> <li>1. The maximum scholarship award is \$3,000. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$150 per course beginning with the student's first attended course and thereafter for those continuously attended courses in their bachelor's program until: (i) the student has maximized the \$3,000 Scholarship amount, or (ii) two years has elapsed from the student's first date of attendance in the their first course, or (iii) the student graduates from</li> </ul>  |

|                                 | <p>their program, whichever comes first. Subsections (i)-(iii) are collectively hereinafter referred to as "Terminating Events".</p> <p>2. Only the applicants selected as Scholarship recipients will be notified by the University of Phoenix.</p>   |
| <p>Maintenance Requirements</p> | <p>In order to continue disbursement of the scholarship award, applicant must meet the following maintenance requirements:</p> <ol style="list-style-type: none"> <li>1. Applicant must remain in a bachelor's program (all coursework attended must be program applicable courses). Awards will only be applied to courses taken as part of their bachelor's program, specific to the original program level award.</li> <li>2. Applicant must successfully pass each course attempted in accordance with their program's requirements as outlined in the academic catalog for all courses. Any withdrawals or courses not successfully passed in accordance with the program requirements will terminate the scholarship.</li> <li>3. Applicant must maintain a cumulative GPA of 3.0 or better for all courses.</li> <li>4. Applicant may not have an unapproved attendance gap greater than 35 days.</li> </ol>  |
| <p>Terms and Conditions</p>     | <p>By applying for a University of Phoenix scholarship and/or accepting the scholarship award, the applicant and/or recipient agrees to the following terms and conditions. Failure to abide by any of the following terms and conditions shall result in either disqualification of the scholarship award or termination of the scholarship award.</p> <ol style="list-style-type: none"> <li>1. All application submissions shall become the property of University of Phoenix, Inc. regardless of applicant being awarded the scholarship. In addition, applicant agrees to execute a University of Phoenix, Inc. 2. Scholarship award is a non-cash award to recipient's University of Phoenix account as outlined on the scholarship application. Scholarship will be applied to the first credit-bearing class with a start date after the award date. No scholarship funds will be applied to previous classes or currently enrolled classes at the time of scholarship award. No check or other cash monies will be disbursed at any time. No exceptions.
