

Summary	<p>All new students who transfer to the University of Phoenix and who (i) apply for and enroll in a University of Phoenix bachelor's degree program; (ii) have completed and transfer in at least 12 but no more than 60 credits combined transfer credits from accredited institution(s); and (iii) apply for this Transfer Student Bachelor's Scholarship – March 2024 ("Scholarship") prior to the deadline and register and post attendance in their first class between March 1st, 2024 and March 31st, 2024 ("Initial Attendance Window") will receive a scholarship worth up to a maximum of \$3,000 each, distributed over twenty courses.</p> <p>Students must begin the admissions application prior to completing this scholarship application</p>
Application Deadline	<p>The Scholarship application will be made available online on February 1st, 2024. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST March 31st, 2024 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.</p>
